Responsibilities may include the following and other duties may be assigned:

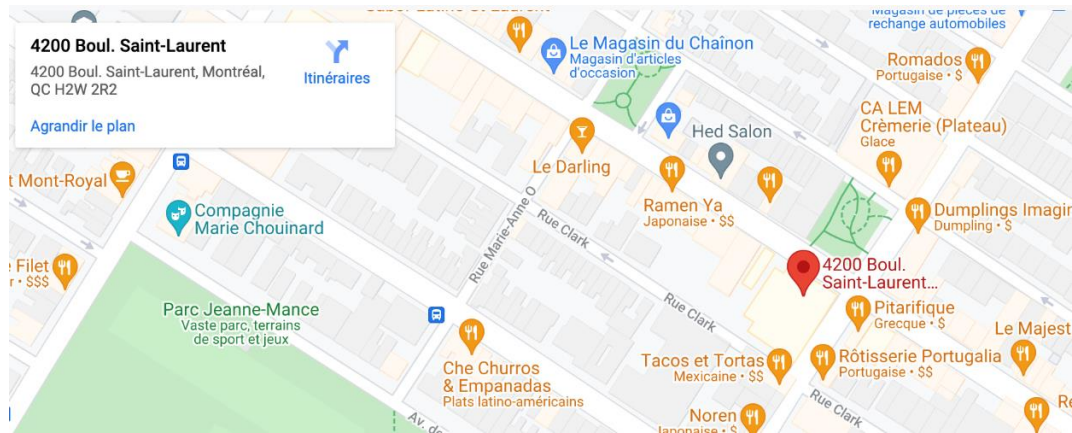
- Execute product Inspection and test plans.
